PARK OPEN FROM 8 AM TO SUNSET UNLESS OTHERWISE SPECIFIED.



1. 24-HOUR FISHING PERMITTED IN DESIGNATED PARKS. PARKING AREAS ASSIGNED FOR THIS ACTIVITY.



2. SPEED LIMIT AS POSTED. UNLICENSED VEHICLES PROHIBITED.



3. PARK VEHICLES IN DESIGNATED AREAS.



4. PROHIBITED...ALCOHOLIC BEVERAGES, NARCOTICS, LITTERING, LOUD OR DISRUPTIVE MUSIC, FIREWORKS, CLIMBING TREES, INDECENT LANGUAGE, IMMORAL ACTIONS, SWIMMING EXCEPT IN COUNTY POOLS.



5. FIRES PERMITTED ONLY IN PATRON OR PARK SUPPLIED GRILLS OR PARK SUPPLIED FIRE RINGS.



6. PETS WELCOME WHEN UNDER CONTROL AND KEPT ON A LEASH NO LONGER THAN SIX FEET, EXCEPT IN DESIGNATED FIELD TRAIL AREAS.



7. IT IS UNLAWFUL TO CATCH, MOLEST OR HARM ANY WILDLIFE.



8. HUNTING, SHOOTING, TRAPPING, CARRYING OF FIREARMS, BOWS AND ARROWS OR ANY OTHER OFFENSIVE WEAPON IS PROHIBITED.



9. IT IS PROHIBITED TO REMOVE OR DAMAGE ANY NATURAL OR MAN-MADE PROPERTY.



10. FOLLOWING ACTIVITIES BY PERMIT ONLY...CAMPING, WATERCRAFT, HORSEBACK RIDING, SOLICITING, PEDDLING.



11. ALL GLASS BEVERAGES AND FOOD CONTAINERS ARE PROHIBITED IN THE PARKS.
